## Policy

### EUROPEAN UNION

#### **European Commission proposals for modernisation of EU copyright rules**

At the State of the Union the European Commission presented its proposals on the modernisation of EU copyright rules. The plans aim to boost cultural diversity in Europe and should make more content available online. The proposals are part of the Commission's [strategy for a Digital Single Market](#). In its [accompanying Communication](#) the Commission states that their '[proposal for a Directive on Copyright in the Digital Single Market](#) introduces solutions for easier licensing of rights by cultural heritage institutions'. Commission Vice-President Ansip even wrote a [blog post](#) about it. Several heritage institutions and networks have criticised the new proposal for not offering appropriate solutions for the making available of out-of-commerce works. As next step, the proposals will be put up for discussion and approval at the European Parliament and the Council. #### **European Year of Cultural Heritage proposed for 2018 (COM(2016)543 final)**

As was announced earlier this year, the European Commission has now officially proposed to the European Parliament and the Council to designate 2018 as the European Year of Cultural Heritage (EYCH). The overall objective of the EYCH will be to encourage and support the efforts of the Union, Member States, regional and local authorities to protect, safeguard, re-use, enhance, valorise and promote the European cultural heritage. And in particular: it will help to illustrate the role of cultural heritage as a pivotal component of cultural diversity and intercultural dialogue, it will show how heritage can contribute to the economy and society, and it will highlight cultural heritage as an important element of the EU's international dimension. The EYCH will provide the framework for events, conferences, debates, information and awareness campaigns, sharing of good practices and research and innovation activities at European, national, regional or local level. It will be implemented using existing EU programmes. ### COUNCIL OF EUROPE

#### **Resolution and Recommendation on culture and democracy**

The Parliamentary Assembly of the Council of Europe has adopted [a Resolution and a Recommendation on culture and democracy](#). The PACE stresses that culture can play an important role in upholding democratic principles and values, and building inclusive societies. The two documents follow on [a report on this topic](#) by MP Ms Vesna Marjanović. The Indicator Framework on Culture and Democracy (IFCD) is mentioned as a tool for evaluating policies and to promote political commitment and investments in the cultural sphere. The IFCD will be launched on 14 October 2016 during [a joint event](#) of the Council of Europe and the European Commission.

## Funding and investments

### CREATIVE EUROPE

The Creative Europe programme aims to support culture and audiovisual sectors in Europe and encourages players to operate across Europe, to reach new audiences and to develop skills needed in the digital age. The [call for proposals for European Cooperation Projects 2017 \(EACEA/45/2016\)](#) under the Culture sub-programme was delayed, but has now been published. The deadline of the call

is 23 November 2016. The call for [European Networks \(four-year framework partnerships 2017-2020\)](#) has also been published, with a deadline for applications on 25 November 2016. It is not clear yet when the call for [European Platforms](#) will open. The new [annual work programme](#) (2017) for the implementation of the Creative Europe Programme provides more details on these calls. ### **Cultural and creative sectors guarantee facility launched**

The European Commission and the European Investment Fund (EIF) have launched a new guarantee facility under the Creative Europe programme to support SMEs in cultural and creative sectors. The financial mechanism provides guarantees to lending and credit institutions, so called financial intermediaries, to encourage them to offer financing for cultural and creative sectors initiatives. The guarantee facility should help to increase the numbers of loans available. Read more about the guarantee facility in this [press release](#) and [presentation](#).

### **EUROPE FOR CITIZENS**

The Europe for Citizens programme aims to strengthen remembrance and to enhance civic participation at EU level. Under the strand 'European remembrance', the Programme promotes debate, reflection and cooperation in the field of European integration and remembrance. The 'Democratic engagement and civic participation' strand supports projects aimed at enhancing democratic participation, solidarity and involvement at EU level. [These are the priorities](#) for 2016-2020. Currently, there are no calls for proposals open for applications. The next deadlines for calls under both strands will be in March 2017. ### **ERASMUS+**

The Erasmus+ programme aims to boost skills and employability, as well as modernising education, training, and youth work in Europe. The 2016 [call for proposals](#) supports several kinds of actions in education and training such as knowledge and sector skills alliances and strategic partnerships. ### **JPI ON CULTURAL HERITAGE AND GLOBAL CHANGE**

The Joint Programming Initiative on Cultural Heritage and Global Change (JPI CH) supports the alignment of cultural heritage research in Europe in order to avoid fragmentation and to maximize the efficiency and added-value of national investments. [These](#) are some of the research projects granted under previous JPI CH joint calls. In 2016 the JPI CH launched [a new 4-year \(Horizon 2020\) project](#) which will support further alignment and joint activities. During this 4-year phase at least one call is foreseen, although the ambition is to realize 4 complementary calls each with a specific thematic focus. Themes that might be included are identity and perception, digital heritage, changing environments, and conservation and protection. More information will be available later this year. ### **HORIZON 2020**

Horizon 2020 is the EU's main funding programme for research and innovation in Europe. It is a financial instrument implementing the Innovation Union, a Europe 2020 flagship initiative aimed at securing Europe's global competitiveness. The business and academic world are also challenged to come up with solutions and ideas to tackle societal issues that arise across Europe, such as climate change and an ageing population.

### **Cultural heritage research and innovation in 2016 and 2017**

Over €100 million is available this term (2016-17) for research and innovation in the field of cultural heritage. The H2020 programme is built around three pillars: Excellent Science, Industrial Leadership and Societal Challenges and some horizontal actions. Depending on your work area or research interest opportunities might be found under all pillars. ### **Preparing of new Work Programmes 2018-2020**

Preparations for the new Work Programmes have started. Stakeholder consultations and consultations with Member States are taking place in the first three quarters of 2016. The results of stakeholder consultations and Advisory Group recommendations provide input for so-called 'Scoping papers', which are the basis for new Work Programmes 2018-2020. ### **EUROPEAN TERRITORIAL COOPERATION (INTERREG V)**

[Interreg V 2014-2020 \(European Territorial Cooperation\)](#) is a framework for the implementation of joint actions and policy exchanges in Europe between national, regional and local actors from different Member States. The framework is part of the Cohesion Policy and promotes innovation, a better environment and harmonious economic, social and territorial development of the Union as a whole. Interreg is built around three strands of cooperation: cross-border (Interreg A, 60 cooperation programmes), transnational (Interreg B, 15 cooperation programmes) and interregional (Interreg C, 4 cooperation programmes.). There are [11 thematic objectives](#) which guide the ERDF investments 2014-2020 of which Interreg is part. Conserving, protecting, promoting and developing natural and cultural heritage is one of the [investment priorities](#) (priority 6c).

### **Interreg Europe (former IVC)**

Interreg Europe focuses on policy instruments for regional development, in particular the Structural Funds programmes. The programme co-finances projects and exchange platforms in which regional and local authorities (and other partners) can exchange good examples and ideas to improve their policy instruments. Specific objective 4.1 (see page 21-23 of [Programme Manual](#)) includes support to cultural heritage. The latest call closed on 13 May 2016, but a new call in 2017 is considered very likely. The monitoring committee of the programme will probably decide on a new call for proposals by the end of 2016. For more information, see [this page](#).

### **URBACT**

URBACT supports networks for cities to facilitate the exchange of good practices in the design and implementation of sustainable integrated urban policies. The programme supports 3 types of Networks. Cultural heritage is one of the urban topics under URBACT. A new call for 15 'Transfer Networks' is expected in Spring 2017 (also see Factsheet 2C, p.43 [Programme Manual](#)). A separate call for good practices is expected in Autumn 2016. For more information, see [this page](#).

### **EUROPEAN MARITIME AND FISHERIES FUND**

This year, three calls for proposals were launched under the European Maritime and Fisheries Fund to foster [blue growth](#) across Europe. One of the calls, '[Blue Labs – innovative solutions for maritime challenges](#)', supports projects aiming at developing innovative solutions relating to four main priorities, one of which is underwater cultural heritage. The call (closed on 31 May 2016) received 50 applications. The annual work programme for 2017 is not yet available.

### **EUROPEANA**

Two new calls have opened in relation to Europeana, Europe's digital platform for cultural heritage. Within the framework of the Connecting Europe Facility (CEF) in Telecom, a call for proposals ([CEF-TC-2016-3](#)) was published to support the development and curation of Thematic Collections of outstanding artefacts, showcasing cultural movements of European significance, on Europeana. Deadline for applications is [15 December 2016](#). And Europeana Research recently opened a [call for Europeana Research Grants](#), which are available for individual research projects which make use of Europeana Collections for research purposes. Deadline for applications is [14 October 2016](#).

### **Study 'Boosting the competitiveness of cultural and creative industries for growth and jobs'**

The title has had a huge impact on both cities, bringing for example a 2,500% increase in guided tours in Mons and 1.4 million attendees at roughly 580 events in Pilsen. For Pilsen, it rejuvenated the city and changed the way in which locals think about culture.'
