Introduction

Our Mission

The European Archaeological Council (Europae Archaeologiae Consilium) is a network of national bodies charged with the management of archaeological heritage throughout Europe, established to support closer and more structured cooperation and exchange of information.

The European Archaeological Council was founded in 1999. It is an international not-for-profit association registered in Belgium. The EAC is governed by [Statutes](#) and its work is guided by the [Amersfoort Agenda](#) (2015) and the Strategic Plan (2022–2027).

Our Purpose

The vision of EAC is that the management of Europe's heritage includes archaeological heritage as a central component, recognising its value to society and economy, and that this heritage is afforded adequate protection as a source of the European collective memory, as an instrument for historical and scientific study, and as a catalyst for collaboration and inclusion.



Annual Meeting and Heritage Symposium

The 26th EAC Annual Meeting and Heritage Symposium was held in Gdańsk, Poland

The event (27–29 March), was co-organised by the National Institute of Cultural Heritage (NID), Archaeological Museum of Gdańsk and Museum of Gdańsk, and was hosted by the Museum of Gdańsk.

The EAC is honoured that the Annual Meeting was granted the Patronage of the Polish Presidency of the Council of the European Union.

The theme of the Heritage Management Symposium was 'Life after life of archaeological archives – accessibility and re-use of archaeological collections in heritage management'. The Symposium was followed by excursions which explored the historic city of Gdańsk and the World Heritage Site of the Castle of the Teutonic Order in Malbork.

Looking Forward

A series of workshops were held in Gdańsk to explore topics raised by members as potential areas for future EAC action.

The workshops generated valuable discussions on these important topics, namely: Heritage Crime; Landscape Management; Climate Change/ Environmental Sustainability and Citizen Science. The resulting questions and challenges to EAC have been published online (see Publications page), and will form the basis of new EAC work in 2026.



EAC General Assembly

Representatives from EAC member organisations and invited observers attended the meeting on 27 March, at which the term of EAC President Ann Degraeve ended, and Marjolein Verschuur was elected to succeed her.

Working Groups

The EAC's working groups are set up to discuss specific issues to inform the development of policy, and to progress the aims and objectives of EAC and its members. Members of the Working Groups are drawn from EAC member organisations, and from other relevant bodies and programmes as appropriate. Some are joint initiatives with partner organisations. The Chairs of the Working Groups met in October to coordinate their programmes.

The **EAA and EAC joint working group on farming, forestry and rural land management** performed its observatory function and reported to the EAC General Assembly, as well as hosting a session at the EAA Annual Meeting in September.

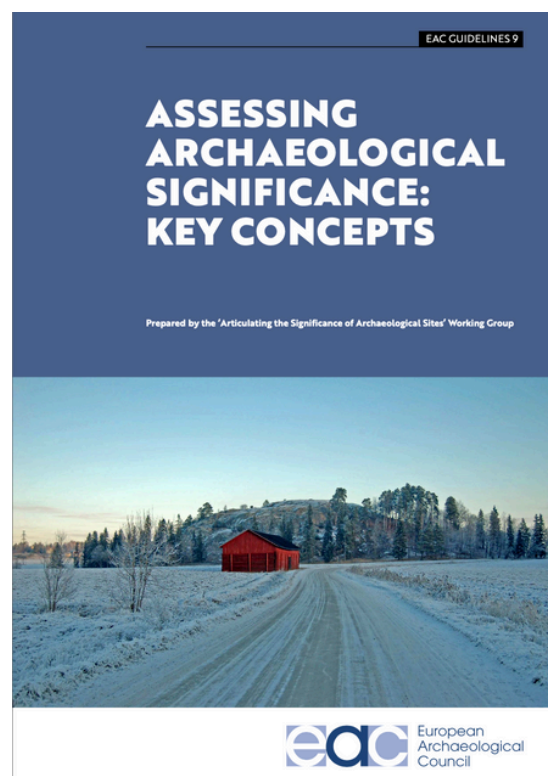
The **Communications** working group continued to support the promotion of EAC, its activities and publications throughout the year.

New guidance publications

Three of the EAC Working Groups launched new guidance at the Annual Meeting. All EAC guidance is published on Zenodo and links can be found on the Publications page or via the EAC website.

The **Articulating Archaeological Significance** group published a short note which provides 'key concepts' for consideration when undertaking the process of evaluating or articulating archaeological significance in various contexts.

They continue to work on a longer contextual document on the topic, for publication in 2026.



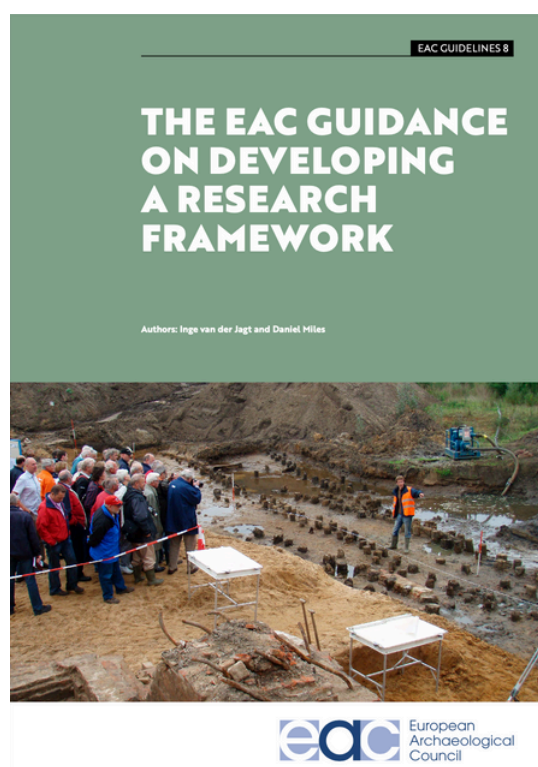
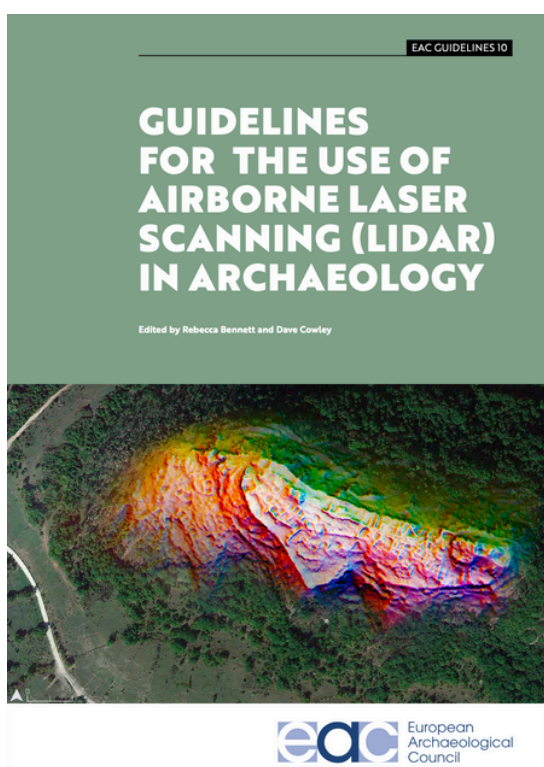
Working Groups

The **Research Frameworks** group published web guidance on developing national research frameworks to support their earlier strategic note on the topic. Having concluded their current work programme, the group closed in 2025.

The **Remote Sensing for Archaeology** AARG/EAC/ISAP working party published guidance on the use of Lidar in Archaeology, and delivered talks promoting the guidance to several organisations.

Archaeological Archives

Following conclusion of their previous work programme on digital archiving, the group have been exploring themes that may constitute work topics for the next few years, particularly the issue of sustainability. The coordination of the Heritage Management Symposium in Gdańsk formed part of this exploration, and key working group members are editing the Proceedings for publication.



Other activities

The EAC attended the EHHF meeting in Valletta, Malta

EAC President Marjolein Verschuur and EAC founder member Adrian Olivier were honoured to be invited to speak at the European Heads of Heritage Forum, hosted by the Superintendence for Cultural Heritage, Malta in September. The topic of the meeting was 'The Valletta Convention: 30 years in practice'. The EAC was pleased to offer its reflections on the past, present and future of the Convention and strengthen links with the EHHF.

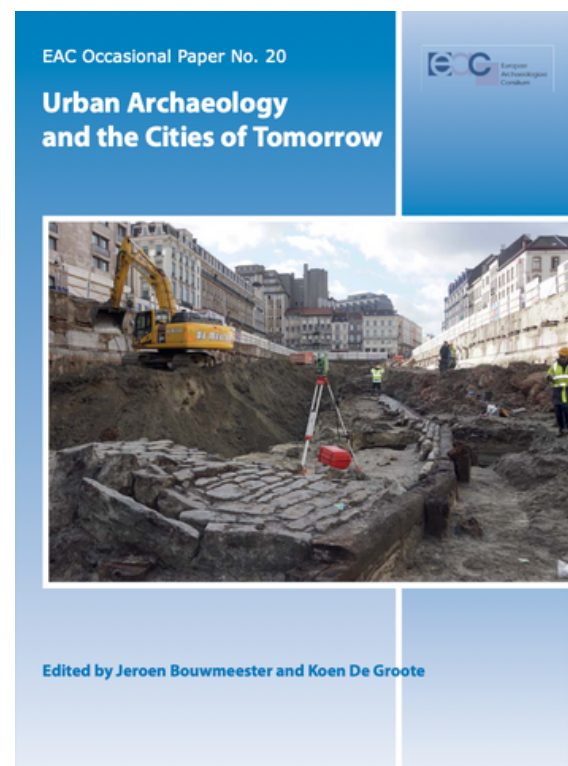
European Affairs Update

The EAC and the European Association of Archaeologists (EAA) jointly published their open access [quarterly newsletter](#) on relevant developments in the field of cultural heritage.

Operational

The Board met three times, hosted by the Archaeological Museum of Gdańsk, Poland; by Durham University, UK; and online. New office holders were welcomed to the roles of EAC President, Vice-President and Secretary, and David Novák (Czechia) joined the Board.

The EAC launched a new website in 2025. It is simpler to navigate, and, we hope, makes it easier to find the EAC's publications and events.

Looking Forward to 2026

The 2026 Annual Meeting and Heritage Symposium

The 27th EAC General Assembly and Heritage Symposium will be held on 19–21 March 2026 in Altamira, Santillana del Mar, Spain. The event is organised by the Ministry of Culture of Spain, and is hosted by the Museum of Altamira.

The theme of the heritage symposium is **'Bridging Borders in Heritage Protection: towards best practice for prevention of archaeological crime'**.

This is the first EAC Annual Meeting to be held in southern Europe for a number of years, and the EAC is grateful to the hosts for providing the opportunity to forge closer connections in the region.

Looking Forward

The EAC will begin to review its Strategic Plan 2022–2027 in 2026. In conjunction with the results of the Altamira Symposium and the rest of the Looking Forward initiative, this will enable the EAC to plan its work programme for the next period. We anticipate proposals for new products, working groups and other initiatives.

New publications

Next year will see the publication of *Articulating the Significance of Archaeological Sites* (EAC Guidelines 11); & the *Proceedings of the 2025 Symposium on the topic of Archaeological Archiving*.
