EUROPEAN UNION

General budget of the European Union for the financial year 2023

3 Oct 2022: The Committee on Culture and Education (CULT) voted on its opinion on the General budget of the European Union for the financial year 2023. The Committee highlighted the need to continue the support for the cultural and creative sectors and industries, as well as the sports sector, that have been affected by the COVID-19 pandemic and its long-lasting negative effects, as well as the need to urgently address the new priorities linked to the war in Ukraine. The opinion called for increased support to Erasmus+, European Capitals of Culture, Creative Europe, Horizon Europe, and the Citizens, Equality, Rights and Values Programme, and opposed cuts in the Directorate-General for Communication. New European Agenda for Culture

3 Oct 2022: the CULT committee deliberated on a draft report on implementing the New European Agenda for Culture and the EU Strategy for International Cultural Relations. They deemed that good progress has been made in implementing the Agenda's objectives. Nevertheless, more ambition and an increased commitment to following up on project results are needed. For this, the rapporteur believed that a fully-fledged strategy is needed, including more significant financial and human resources, as well as rethinking monitoring and evaluation methods, to ensure that positive project outcomes are not lost over time. Culture and Education committee to visit Budapest

28 Oct 2022: A delegation of the CULT Committee will travel to Budapest for insights into recent developments in the country's cultural, education and media policies. The delegation is set to meet their counterparts in the Hungarian parliament (National Assembly), the Culture and Innovation Minister, the Regional Development Minister, and representatives from Hungary's National Media and Infocommunications Authority. MEPs will also meet the Budapest Deputy Major and representatives from the Liszt Ferenc Academy of Music, the Hungarian Academy of Science, Central European University, and figures from media and civil society, including NGOs dealing with refugees. The targeted destruction of Ukrainian cultural heritage is a war crime, MEPs say

20 Oct 2022: The European Parliament called on the EU to urgently support Ukraine in documenting attacks against its cultural heritage and to help with reconstruction. MEPs stressed that Russia's attempt to eradicate the Ukrainian identity and culture, also through targeted acts of destruction on cultural heritage sites, is a war crime under the Hague Convention. The text urges the EU to support Ukraine in documenting attacks against its cultural heritage and to use EU funding to restore cultural sites. The emergency needs of the culture and cultural heritage sectors should be included in the EU's humanitarian support to Ukraine, MEPs said. Find out more [here](#).

Council agrees on stricter rules for energy performance of buildings

Sep 2022: The European Council reached an agreement (general approach) on a proposal to revise the Energy Performance of Buildings Directive. The main objectives of the revision are that all new buildings should be zero-emission buildings by 2030, and that existing buildings should be transformed into zero-emission buildings by 2050. 35 years of Cultural Routes: Safeguarding European Values, Heritage, and Dialogue

Oct 2022: the Council of Europe Cultural Routes' programme celebrated its 35th anniversary, at the 11th Advisory Forum in Chania, Crete (Greece) on 5-7 October, with a special event to highlight the relevance of Cultural Routes for the promotion of cultural diversity, intercultural dialogue and sustainable tourism. It underlined the growing relevance of the Cultural Routes methodology and practices in promoting Europe's shared cultural heritage while fostering viable local development. The Forum discussed trends and challenges in relation to Cultural Routes, providing a platform for sharing experiences, reviewing

progress, analysing professional practices, launching new initiatives and developing partnerships across Europe and beyond. Find out more [here](#).

International Youth Day

12 Aug 2022: In 2022, the theme of the International Youth Day was "Intergenerational Solidarity: Creating a World for All Ages". The Congress Spokesperson on Youth stressed the need to develop strong intergenerational connections to build more inclusive and democratic societies: "Our towns, cities and regions offer the best platforms to encourage intergenerational exchange. Multiannual Financial framework (MFF)

The multiannual financial framework for 2021-2027 is in place as of 1 January 2021. €1.074 trillion is available for beneficiaries of EU funding during these seven years. CREATIVE EUROPE

Creative Europe 2023 work programme adopted

Sep 2022: European Commission adopted the 2023 work programme for Creative Europe. The programme will continue to contribute to the implementation of the New European Bauhaus initiative through its CULTURE and CROSS SECTORAL strands. Specifically, the programme plans to contribute to the New European Bauhaus will be in the following fields/actions:

- [Mobility of artists and their works](#): the new mobility instrument, Culture Moves Europe, will also stimulate artistic residencies linked to the New European Bauhaus.
- [European Capitals of Culture \(ECOC\)](#): a resourceful laboratory for policy reflection and experimentation on culture and Europe at a city level, promoting sustainability, participatory approaches and cross-sectoral linkages.
- [Creative Innovation Lab](#): will bring together stakeholders from audiovisual, cultural and creative industries and the technology sphere, to collaborate and undertake projects to deploy innovative digital solutions to respond to the common challenges and opportunities of the digital transition across the cultural and creative sectors. One of the focuses for projects is greening and circular economy thinking, including innovation for sustainability, inclusion and well-being in line with the priorities of the new European Bauhaus.
- [European Cooperation projects](#): this action will support projects involving a large diversity of players active in different cultural and creative sectors, to carry out a broad spectrum of activities and initiatives. The action is anchored in the policy framework of the Culture strand of the Creative Europe Programme and its cross-cutting issues (inclusiveness, reduction of environmental impact and gender equality).

THE CITIZENSHIP, EQUALITY, RIGHTS AND VALUES PROGRAMME (CERV)

Citizens, Equality, Rights and Values (CERV): EU program 2021-2027

The "Europe for Citizens" program, together with the REC (Rights, Equality and Citizenship) program and Daphne, form the EU program "Citizens, Equality, Rights and Values 2021-2027" - CERV for short. CERV - with a budget of around EUR 1.55 billion - consists of four funding areas with the general goal of maintaining and developing open, rights-based, democratic, equal and inclusive societies. The priorities of "Europe for Citizens" remain.

HORIZON EUROPE

Horizon Europe is the EU's key funding programme for 2021-27 for research and innovation with a [budget of €95.5 billion](#). It tackles climate change, helps to achieve the UN's Sustainable Development Goals and boosts the EU's competitiveness and growth. The programme facilitates collaboration and strengthens the impact of research and innovation in developing, supporting and implementing EU policies while tackling global challenges. It supports creating and better dispersing of excellent knowledge and technologies, creates jobs, fully engages the EU's talent pool, boosts economic growth, promotes industrial competitiveness and optimises investment impact within a strengthened European Research Area. Legal entities from the EU and associated countries can participate.

The [new Horizon Europe](#) programme is structured around three pillars that are divided into specific subjects. For the first time ever, the authors of the programme included a cluster dedicated to Culture, Creativity and Inclusivity.

Efficient, sustainable and inclusive energy use (HORIZON-CL5-2022-D4-02)

Forthcoming Calls:

Collaborative cloud: €110 million for Horizon Europe calls until 2025

With an envisaged budget of €110 million until 2025, the Collaborative Cloud will be a unique infrastructure that will enable unprecedented transdisciplinary and large-scale collaboration between specialists, such as cultural heritage scholars, curators, archivists and conservators. Following an impact assessment (Apr 2022), the European Commission plans to launch several calls under Horizon Europe. These will be run in the framework of the actions for Cultural Heritage, Cultural and Creative Industries in 2023, 2024 and 2025. Find out more [here](#).

UK participation in Horizon Europe: The Trade and Cooperation Agreement between the EU and the UK provides for the possibility of associating the United Kingdom to Horizon Europe, subject to the adoption of a Protocol. As this Protocol has not been adopted so far, the UK is still considered to be "non-associated" to Horizon Europe. The successful proposals of applicants based in a country in the process of associating to Horizon Europe will be eligible for funding only if the relevant Horizon Europe association agreement

applies by the time of the signature of the grant agreement. However, successful applicants from UK host institutions can still be funded provided they move to a host institution in an eligible country. If the UK is unable to associate to Horizon Europe, the government will introduce a programme of international science, research and innovation collaborations, including immediate measures to stabilise the sector. POST-2020 EUROPEAN TERRITORIAL COOPERATION PROGRAMMES "INTERREG"

Interreg programmes for the 2021–2027 period were agreed in January 2022. Interreg funds projects that bring together policy organisations from across Europe. For four years, they learn from each other and work together on a shared policy issue. The lessons they learn lead to the improvement of regional policies and a more sustainable economic, social and environmental impact on the ground for the people and the place they serve.

Alliance for Research on Cultural Heritage in Europe (ARCHE)

Sep 2022: the ARCHE project (Alliance for Research on Cultural Heritage in Europe) held kick off meeting in Paris. Funded by the European Commission and gathering 24 partners from 18 European countries for three years, it will develop a pan European framework for a holistic approach to Cultural Heritage Research and Innovation, by creating a spearheading coordination network of researchers, innovators, heritage professionals, institutional bodies and citizens. With the Fondation des Sciences du Patrimoine as project coordinator and a budget of three millions euros, this Coordination and Support Action (CSA) will engage all Cultural Heritage actors in member States / Associated Countries in the co-design of Research and

Innovation strategies and roadmaps that lead to Research and Innovation initiatives requiring multidisciplinary approaches and skills.

The Cultural Heritage Research and Innovation landscape has changed significantly over the past few years. New political, technological and socio-economic parameters put emphasis on improving protection, conservation and restoration efficiency of European cultural heritage with green technologies, as well as developing and further exploiting high quality digitisation, open access and curation of digital assets. The need also exists to enhance the innovation potential and competitive edge of the Cultural and Creative sectors. A detailed assessment of research and innovation gaps and needs for the next decade will be the basis for designing a Strategic Research and Innovation Agenda (SRIA) for joint programming aiming to increase awareness of heritage and European sense of belonging. A new purpose-built governance structure will be proposed that will effectively involve existing networks and new partners from relevant scientific disciplines and industries. It will also promote intensive and wide-ranging collaboration between cultural heritage, the arts, and the CCS. The SRIA and governance structure will be tested in a pilot operation in the third and final year. Find out more [here](#) and [here](#).

Europa Nostra presents the Prague Manifesto “For a Value-based and Culture-driven Europe”

Oct 2022: Europa Nostra released the Prague Manifesto “For a Value-based and Culture-driven Europe”. The Manifesto contains the key policy messages formulated during the European Cultural Heritage Summit 2022, and especially during its concluding event – the European Heritage Policy Agora. The Prague Manifesto puts forward 7 concrete and actionable proposals for culture and heritage to be fully recognised and deployed in building a value-based and culture-driven Europe. These proposals aim at unleashing the potential of culture and heritage for the implementation of the New European Bauhaus initiative, for the advancement of a value-based European Political Union, as strategic assets to foster international cooperation, to support and speed-up Europe’s transition to a green, climate-neutral continent as well as to achieve the UN Sustainable Development Goals, among others. UN General Assembly: Development and cultural rights

Aug 2022: In her first report to the General Assembly, the Special Rapporteur in the field of cultural rights, Alexandra Xanthaki, addresses the role of culture in sustainable development, including the cultures of development, with a view to assessing how cultural diversity and cultural rights have been mainstreamed in the 2030 Agenda for Sustainable Development so far; taking stock of the experiences in leveraging cultural resources and cultural rights in the pursuit of a more sustainable development, as well as the weaknesses encountered in doing so; and highlighting areas where increased cultural awareness may contribute to reaching the Sustainable Development Goals during the second half of the implementation timeline of the 2030 Agenda. MONDIACULT 2022 : States adopt historic Declaration for Culture

Oct 2022: 150 States unanimously adopted an ambitious Declaration for Culture at the end of MONDIACULT 2022, the largest world conference devoted to culture in the last 40 years, which brought together nearly 2,600 participants over three days in Mexico City. At UNESCO’s and Mexico’s invitation, 150 States sent delegations to the conference, 135 of them were represented at the highest level by ministers of culture. In the Declaration, the fruit of ten months of multilateral negotiations led by UNESCO, States affirm for the first time that culture is a “global public good”. Consequently, States call for culture to be included “as a specific objective in its own right” among the next United Nations Sustainable Development Goals. Other outcomes of MONDIACULT include the establishment, from 2025 onwards, of a World Forum on Cultural Policies, to be organized by UNESCO every four years. The debates of the Forum will be informed by a World Report on Cultural Policies which the Organization will produce. Find out more [here](#).

MONDIACULT 2022 : UNESCO and Interpol announce virtual museum

Oct 2022: UNESCO and Interpol will set up a virtual museum of stolen cultural property for educational purposes and as a reference for people in doubt about the origin of a piece. UNESCO’s proposal is part of agreements passed at MONDIACULT 2022. One of the major goals of the virtual museum, which will be established over coming three years and supported by the International Criminal Police Organization (Interpol), is to help prevent non-accredited cultural goods sale. The global Climate Heritage Network launches new Action Plan 2022-2024

Sep 2022: The Climate Heritage Network (CHN) is a global network of more than 250 member organisations committed to supporting communities in achieving the ambitions of the Paris Agreement by scaling up culture-based and heritage-led climate action. The new CHN Action Plan (2022-2024) promotes the theory that change happens by unlocking the power of culture to empower people to imagine and realise low-carbon, just, climate resilient futures. At the core of the Plan are two goals for 2022-2024: (1) Increase the quantity and quality of culture-based climate action at all levels, and (2) Transform climate policy by embedding culture and heritage into strategies to realise low-carbon, just and fair, climate resilient living. Odesa's candidacy to receive World Heritage status announced at UNESCO

Oct 2022: President Zelensky announced in a pre-recorded video message to the 58 Member States of UNESCO's Executive Board. He formalised the World Heritage nomination of the historic centre of Odesa and expressed "gratitude" to the UN organization for actions it has led in Ukraine under its mandate, and called for an "expansion of joint efforts" to protect the country's cultural heritage.
