## Policy

### EUROPEAN UNION

#### **Council and European Parliament present their position on the European Year of Cultural Heritage 2018**

During its [meeting on 22 November 2016](#), the EU Council of Ministers of Culture adopted [a general approach](#) regarding the proposal for a decision on a European Year of Cultural Heritage (EYCH 2018) ([COM\(2016\)543 final](#)), which was submitted by the European Commission in August 2016. In the general approach, the Council introduces a new overall objective and several other changes to the Commission proposal. The European Parliament's [CULT Committee also presented its position](#) on the EYCH 2018 in a [draft report](#). The Committee underlines its support for the initiative, but also calls for a specific budget line and active participation of all relevant stakeholders. The European Parliament, the Council and the European Commission are now starting negotiations and a final decision is expected soon. In the meantime the European Heritage Alliance network, representing many heritage-related European and international networks, has started [an advocacy campaign](#) to ensure that the EYCH 2018 is supported with adequate financial resources at all levels of governance.

#### **Council agrees on inclusion of EFTA/EEA countries in European Capitals of Culture 2020-2033**

The Council of the EU has reached political agreement on the [Commission's proposal to amend Decision No 445/2014/EU](#) establishing a Union action for the European Capitals of Culture for the years 2020 to 2033. The amendment extends the open competition for cities from candidate countries/potential candidates to cities from EFTA/EEA countries. It is expected that the decision will be adopted under the Maltese Presidency. For more details, see the 'Outcome of the Council meeting' on [this webpage](#).

#### **Public consultation on rules on the on import of cultural goods**

Recently, the European Commission launched a [public consultation on rules on the import of cultural goods](#). This public consultation aims to gather input from all interested stakeholders to be taken into consideration in the preparation of legislative proposals. The Commission is considering to adopt measures that will counter the illicit trafficking in cultural goods from third countries more effectively. #### **Library and cultural heritage sector responds to Commission proposal on Copyright in the Digital Single Market**

Several important players in the European library and cultural heritage sector have [published a joint statement](#) on the European Commission's proposal on Copyright in the Digital Single Market. This proposal is part of a package of legislative proposals for the [modernisation of EU copyright rules](#) presented by the Commission in September 2016 (see [European Affairs Update – Oct 2016](#)). It will be discussed by the European Parliament and the Council early this year.

### COUNCIL OF EUROPE

#### **Indicator Framework on Culture and Democracy (IFCD) launched**

The [Council of Europe's Indicator Framework on Culture and Democracy \(IFCD\)](#) has been [launched on 14 October 2016](#). The IFCD is 'a tool for assessing and optimising cultural policies on the basis of reliable, comparative data and for examining links between culture and democracy within and among

Council of Europe member states'. It will enable more evidence based policy-making and investments, mapping of European trends, as well as evaluation of a country's situation and comparison with other countries. The IFCD has been developed by the Council of Europe in collaboration with the Hertie School of Governance and with support from the European Cultural Foundation and member states. ### **Update on European Cultural Heritage Strategy for the 21st century (Strategy 21)**

The draft [European Cultural Heritage Strategy](#) and Recommendation (see [European Affairs Update – Jul 2016](#)) have been transmitted to the Committee of Ministers and will be considered for adoption in the next months. The [Cypriot Chairmanship \(Nov 2016 – May 2017\) has plans to organise a launching event](#) for the promotion of the Strategy and the Recommendation.

### **Update on draft Convention on Offences relating to Cultural Property**

Last year the Council of Europe started preparations for a new criminal law convention to combat the illicit trafficking of cultural property. The new [Committee on Offences relating to Cultural Property \(PC-IBC\)](#) is working on a draft Convention, which will supersede and replace the [European Convention on Offences relating to Cultural Property \(ETS No.119\)](#). It is expected that the Convention will be ready by the end of 2017. A [high-level colloquium dedicated to the topic](#) of the Convention was hosted by the Council of Europe and the Cypriot Chairmanship of the Committee of Ministers on 13 January 2017 in Strasbourg, France.

## **Funding and investments**

### **CREATIVE EUROPE**

The Creative Europe programme aims to support culture and audiovisual sectors in Europe and encourages players to operate across Europe, to reach new audiences and to develop skills needed in the digital age. Currently, no calls are open under the Culture sub-programme. The next call for [European Cooperation Projects](#) is expected after the summer, with a deadline in October 2017. ### **EUROPE FOR CITIZENS**

The Europe for Citizens programme aims to strengthen remembrance and to enhance civic participation at EU level. Under the strand 'European remembrance', the programme promotes debate, reflection and cooperation in the field of European integration and remembrance. The 'Democratic engagement and civic participation' strand supports projects aimed at enhancing democratic participation, solidarity and involvement at EU level. ### **ERASMUS+**

The Erasmus+ programme aims to boost skills and employability, as well as modernising education, training, and youth work in Europe. The 2017 [call for proposals](#) supports several kinds of actions in education and training such as sector skills alliances and strategic partnerships. ### **JPI ON CULTURAL HERITAGE AND GLOBAL CHANGE**

The Joint Programming Initiative on Cultural Heritage and Global Change (JPI CH) supports the alignment of cultural heritage research in Europe in order to avoid fragmentation and to maximize the efficiency and added-value of national investments. [These](#) are some of the research projects granted under previous JPI CH joint calls. In 2016 the JPI CH launched [a new 4-year \(Horizon 2020\) project](#) which will support further alignment and joint activities. During this 4-year phase at least one call is foreseen, although the ambition is to realize 4 complementary calls each with a specific thematic focus. Themes that might be included are identity and perception, digital heritage, changing environments, and conservation and protection. Explore more about the JPI CH on this [website](#).

## HORIZON 2020

Horizon 2020 is the EU's main funding programme for research and innovation in Europe. It is a financial instrument implementing the Innovation Union, a Europe 2020 flagship initiative aimed at securing Europe's global competitiveness. The business and academic world are also challenged to come up with solutions and ideas to tackle societal issues that arise across Europe, such as climate change and an ageing population.

### **Cultural heritage research and innovation in 2016 and 2017**

Over €100 million is available this term (2016-17) for research and innovation in the field of cultural heritage. The H2020 programme is built around three pillars: Excellent Science, Industrial Leadership and Societal Challenges and some horizontal actions. Depending on your work area or research interest opportunities might be found under all pillars. ### **Preparation of new Work Programmes 2018-2020**

Preparations for the new Work Programmes 2018-2020 started in 2016. Stakeholder consultations and consultations with Member States have taken place in the first three quarters of 2016. The results of stakeholder consultations and Advisory Group recommendations provide input for so-called 'scoping papers', which are the basis for the new Work Programmes 2018-2020.

The European Commission has now published [17 scoping papers](#) and one general [overarching document](#) for the Work Programmes 2018-2020. These scoping papers are working documents and therefore don't have any formal status. They do give a good idea of possible themes and priorities, as they will guide the preparation of the new work programmes. It might be worth to check out relevant sections of the scoping papers for SC5 (2.6 'Protecting and valorizing our natural and cultural assets') and SC6 (2.2 'Cultural and technological transformations for human and social progress'). The adoption and publication of the work programmes are expected in October 2017.

### **EUROPEAN TERRITORIAL COOPERATION (INTERREG V)**

[Interreg V 2014-2020 \(European Territorial Cooperation\)](#) is a framework for the implementation of joint actions and policy exchanges in Europe between national, regional and local actors from different Member States. The framework is part of the Cohesion Policy and promotes innovation, a better environment and harmonious economic, social and territorial development of the Union as a whole. Interreg is built around three strands of cooperation: cross-border (Interreg A, 60 cooperation programmes), transnational (Interreg B, 15 cooperation programmes) and interregional (Interreg C, 4 cooperation programmes). There are [11 thematic objectives](#) which guide the ERDF investments 2014-2020 of which Interreg is part. Conserving, protecting, promoting and developing natural and cultural heritage is one of the [investment priorities](#) (priority 6c).

### **Interreg Europe (former IVC)**

Interreg Europe focuses on policy instruments for regional development, in particular the Structural Funds programmes. The programme co-finances projects and exchange platforms in which regional and local authorities (and other partners) can exchange good examples and ideas on public policy to improve the strategies for their citizens and communities. Specific objective 4.1 (see page 21-23 of [Programme Manual](#)) includes support to cultural heritage. A [third call for project proposals](#) will run from 1 March 2017 to 30 June 2017. The details of the call will be published on the website soon. For more information, see [this page](#).

The previous two calls resulted in 130 approved projects, of which [nine projects focus on development and improvement of cultural heritage policies](#). Four projects address the topic of cultural heritage and five projects work on both, cultural and natural heritage.

### **URBACT**

URBACT supports networks for cities to facilitate the exchange of good practices in the design and implementation of sustainable integrated urban policies. The programme supports 3 types of Networks. Cultural heritage is one of the urban topics under URBACT. A new call for 15 'Transfer Networks' is expected later this year (also see Factsheet 2C, p.43 [Programme Manual](#)). ### **Interreg Europe policy brief on role of regional cooperation in preserving cultural heritage**

Interreg Europe has [published a policy brief](#) on the role of regional cooperation in the protection and sustainable management of cultural heritage. UNESCO has published a new military manual for the protection of cultural heritage. It was launched during a high-level panel discussion on 'Targeting Heritage: in search of new paradigms – save heritage through dialogue'. Participants discussed how to make protection of heritage an integral part of sustainable strategies to foster development, peace and security. The [Military Manual on Protection of Cultural Property](#) 'serves as a practical guide to the implementation by military forces of the rules of international law for the protection of cultural property in armed conflict'. #### **Abu Dhabi Declaration on the protection of endangered cultural heritage in armed conflict**

Heads of States and Ministers from 40 countries and representatives from several international organisations participated in the 'Conference on Safeguarding Endangered Cultural Heritage', which was held in Abu Dhabi (United Arab Emirates) on 2-3 December 2016. The conference was a joint French-United Arab Emirates initiative and was held under the patronage of UNESCO. The event focussed on the protection of cultural heritage in places of conflict from terrorism and illicit trafficking. The conference concluded with the adoption of the [Abu Dhabi Declaration](#). It commits the 40 participating States to create an international fund open to public and private contributions and an international network of safe havens for endangered cultural property.
