EUROPEAN UNION

EU budget 2019 approved: focus on the young, innovation and migration

For next year's budget, MEPs have secured better support for students, unemployed youngsters and researchers. Commitment appropriations for 2019 total €165.8 billion, which is an increase of 3.2% compared with the 2018 budget as amended over the past months. Payments amount to €148.2 billion, 2.4% more than in 2018. After Council formally approved the [conciliation agreement](#) with Parliament on the 2019 budget on 7 December, Parliament approved the budget on 12 December by 451 votes to 142, with 78 abstentions. A new Work Plan for Culture to start in 2019

The Council of the European Union adopted Conclusions on the [Work Plan for Culture 2019-2022](#). The plan is considered a strategic instrument setting priorities and defining concrete actions to address the increasing shift to digital technologies, globalisation and growing societal diversity in the area of cultural policy.

The Work Plan, adopted on 27 November 2018, sets out the following five priorities for European cooperation in cultural policy-making:

- Sustainability in cultural heritage
- Cohesion and well-being
- An ecosystem supporting artists, cultural and creative professionals and European content
- Gender equality
- International cultural relations

The priorities are complemented by 17 concrete actions to be carried out over a period of four years. The Work Plan is part of the European Agenda for Culture [strategic framework](#).

No Europe without culture: new campaign launched

EU citizens are called to the ballot boxes to take part in European Parliamentary elections 23-26 May 2019. In the run-up to the vote, [Culture Action Europe calls on political parties to recognise culture's contribution to Europe as a necessary source of unity and a force for cooperation and mutual understanding](#).

Culture Action Europe (CAE) sees the 2019 European elections as a re-vindication of Europe's core values and democracy in times when both are under threat. With many challenges Europe is facing, from climate change to increasing pressures on freedom of artistic and cultural expression, migration, populism, the digital transition, youth unemployment to data privacy, it has never been a more important time to propose ambitious and purposeful cultural policies at the European level that work for a strong Europe and its citizens. In this critical moment it is also vital that Europeans cast their opinions as to how they would like to be represented on Europe's political stage.

European Union Youth Strategy

[The Council adopted a Resolution on the new EU Youth Strategy 2019-2027 \(14080/18\)](#). Ministers agreed that the cross-sectoral approach of the strategy is aimed at addressing the needs of young people in other EU policy areas. Ministers also showed support for the Commission's view that the document is very ambitious, in particular in relation to the aim of reaching disadvantaged young people.

Strengthening of European content in the digital economy

The Council adopted [conclusions on the strengthening of European content in the digital economy \(13949/18\)](#). The conclusions focus on the following political priorities on the European Union's agenda:

- Fostering diversity, visibility and innovation
- Establishing a level playing field
- Strengthening trust in information and sources
- Improving skills and competences.

Ministers acknowledged the need to ensure the establishment of a EU digital single market. They agreed that the global expansion of digital technologies has significant effects on and implications for all creative sectors, but also provides new opportunities for the European cultural and creative sectors.

European Framework Action on Cultural Heritage

At the [Vienna conference](#) celebrating the end of the historic European Year of Cultural Heritage (December 2018), the European Commission presented a long-expected [European Framework for Action on Cultural Heritage](#) to ensure the legacy of the many fruitful partnerships and initiatives launched during the European Year. Europa Nostra and the German Cultural Heritage Committee took the opportunity to proudly present the symbolic number of 2018 signatures of the Berlin Call to Action to the European Commission at the conference. COUNCIL OF EUROPE

Spain signed the Convention on the Value of Cultural Heritage for Society

On Wednesday 12 December 2018, in the presence of the Deputy Secretary General, Ambassador Manuel Montobbio, Permanent Representative of Spain to the Council of Europe signed the Convention on the Value of Cultural Heritage for Society ([the "Faro Convention", CETS No.199](#)). This signature coincides with the [Regional Seminar of the European Commission / Council of Europe joint project "The Faro Way"](#), taking place in Madrid on 13-14 December 2018. The seminar aims to enhance processes leading to the signing of the Convention, so as to widen the group of member States joining the Faro Convention.

Adoption of a Recommendation on culture's contribution to strengthening the internet as an emancipatory force

The Committee of Ministers adopted [Recommendation CM/Rec\(2018\)10 on culture's contribution to strengthening the internet as an emancipatory force](#) on 14 November 2018.

This text recommends that member States draw on culture and cultural players as vital elements for reinforcing the internet and digital media as democratic forces, enlarge the scope of critical digital media and information literacy programmes and use culture's capacity to act as a catalyst for shaping informed citizenship online.

Preserving intangible cultural heritage against uniform lifestyles

The Committee on culture considers that intangible cultural heritage (ICH), which includes traditions or living expressions inherited from the past, such as performing arts and oral traditions, must be safeguarded in Europe, yet industrialisation, urban development and the standardisation of lifestyles constitute a context which places such heritage in a vulnerable position.

Unanimously adopting a draft resolution, based on a report prepared by Andries Gryffroy (Belgium, NR), the Committee called on member States to sign and ratify the UNESCO Convention for the Safeguarding of the Intangible Cultural Heritage and the Council of Europe Framework Convention on the Value of Cultural Heritage for Society (Faro Convention), and "to develop national strategies for safeguarding and enhancing the role of ICH according to the principles laid down in these conventions".

Multiannual Financial framework (MFF)

[The European Council welcomed the intensive preparatory work carried out during the last semester](#) on the future Multiannual Financial Framework and took note of the [Presidency's progress report](#). It called on the incoming Presidency to continue that work and develop an orientation for the next stage of the negotiations, with a view to achieving an agreement in the European Council in autumn 2019.

Proposal for the next research and innovation framework programme

The Commission has published its proposal for [Horizon Europe](#), an ambitious €100 billion research and innovation programme that will succeed Horizon 2020. The proposal was made as part of the EU's proposal for the next [EU long-term budget](#), the multiannual financial framework (MFF). Various building blocks were taken into account including the interim evaluation of Horizon 2020, the Lab-Fab-App report (informally the Lamy report), foresight studies and various other reports.

Erasmus+: an expected budget of €3 billion to be invested in young Europeans and to help create European Universities in 2019

For 2019, funds available for Erasmus+ are expected to increase by €300 million or 10% compared to 2018. The Commission published its 2019 [call for proposals](#) for the [Erasmus+](#) programme. From an expected budget of €3 billion for next year, €30 million has been set aside for dedicated [European Universities](#). This is a new initiative that was endorsed by European Union leaders at the [Gothenburg Social Summit](#) last November, and part of the push towards establishing a [European Education Area](#) by 2025.

[The Council of the European Union reached a partial general approach on a proposal for a Regulation on the Erasmus+ programme \(13943/18\)](#). A partial general approach excludes budget-related issues/figures which are currently being discussed as part of the negotiations on the next multiannual financial framework. Ministers broadly welcomed the expanding of the programme, which will make it more inclusive. They stressed that the greater scope of Erasmus+ will provide new opportunities to more people, in particular to more disadvantaged young citizens. Ministers acknowledged also the key role of Erasmus+ for the establishment by 2025 of the European Education Area. You can view the new Erasmus 2021-2027 Programme [here](#).

Creative Europe Programme (2021 to 2027)

Ministers took note of a progress report on a proposal for a new Creative Europe programme (2021-2027) at the [Council meeting on 26-27 Nov 2018](#). They identified gender equality, diversity, translation and subtitling among the various challenges in the context of the programme. Ministers welcomed the proposal of the European Commission as a key tool for building a Europe of culture. They showed broad support for the sustainable financing of the European Film Academy and the EU Youth Orchestra.

The European Commission adopted its proposal for a new Creative Europe programme (2021-2027) on 30 May 2018 ([9170/18](#) + [ADD 1](#)). The overall budget for 2021-2027, as proposed by the Commission, is EUR 1.85 billion (MEDIA: EUR 1.081 billion, CULTURE: EUR 609 million, Cross-sectoral: EUR 160 million) which would represent an increase of EUR 390 million (approx. 27%) compared to the current programme.

CREATIVE EUROPE

Creative Europe is the European Commission's framework programme for support to the culture and audiovisual sectors. Following on from the previous Culture Programme and MEDIA programme, Creative Europe, with a budget of €1.46 billion, supports Europe's cultural and creative sectors.

530 project proposals were submitted under the call for Support for European Cooperation Projects 2018. EUROPE FOR CITIZENS

The Europe for Citizens programme aims to strengthen remembrance and to enhance civic participation at EU level. Under the strand 'European remembrance' the programme promotes debate, reflection and cooperation in the field of European integration and remembrance. The 'Democratic engagement and civic participation' strand supports projects aimed at enhancing democratic participation, solidarity and involvement at EU level. ERASMUS+

Erasmus+ is the EU's programme to support education, training, youth and sport in Europe. Its budget of €14.7 billion will provide opportunities for over 4 million Europeans to study, train, gain experience, and volunteer abroad.

Set to last until 2020, Erasmus+ merges seven prior programmes and it has opportunities for a wide variety of individuals and organisations.

JPI ON CULTURAL HERITAGE AND GLOBAL CHANGE

The [Joint Programming Initiative on Cultural Heritage and Global Change \(JPI CH\)](#) supports the alignment of cultural heritage research in Europe in order to avoid fragmentation and to maximize the efficiency and added-value of national investments. In 2016 the JPI CH launched [a new 4-year \(Horizon 2020\) project](#) which will support further alignment and joint activities. During this 4-year

phase JPI CH will launch four complementary calls, each with a specific thematic focus. Two calls were completed in 2017. The results of the call on Heritage in Changing Environments will be announced soon. A third call on identity and perception will probably open later this year.

The JPI CH and the Cultural Heritage Agency of the Netherlands organised an [international conference on the best practices of participatory governance of built heritage](#) on 4 October 2018 in Amersfoort, the Netherlands. HORIZON 2020

Horizon 2020 is the EU's main funding programme for research and innovation in Europe. It is a financial instrument implementing the Innovation Union, a Europe 2020 flagship initiative aimed at securing Europe's global competitiveness. The business and academic world are also challenged to come up with solutions and ideas to tackle societal issues that arise across Europe.

The Horizon 2020 programme is built around three pillars: Excellent Science, Industrial Leadership and Societal Challenges and some horizontal actions. Depending on your work area or research interest opportunities might be found under all pillars. Work Programmes 2018-2020

The European Commission has published an updated 2018-2020 Horizon 2020 Work Programme. This update provides some alterations and additional details for the 2019 calls in the 2018-2020 Work Programme initially published in October 2017. The degree of changes varies across the Work Programme parts and while new topics have been added to some calls for proposals (e.g. in Societal Challenge 1), other parts will only see minor corrections and additional information provided (e.g. the European Innovation Council Pilot). The parts of the Work Programme that relate to 2020 are still indicative and will be finalised during 2019. To help future applicants identify the changes easily, the Commission also published the official lists of changes made to each Work Programme part. H2020 underwrite guarantee update

The UK government has updated its information for UK applicants to Horizon 2020. A [technical notice](#) published on 23 August 2018 provides more detail on the H2020 underwrite guarantee, the recent extension to the guarantee and how the government plans to continue to support research and innovation in the UK. It is aimed at all UK organisations who are in receipt of H2020 funding or who are bidding for such funding. It will also be of interest to partner organisations who work with UK participants on Horizon 2020 projects.

The UK and EU's intention is that the eligibility of UK researchers and businesses to participate in H2020 will remain unchanged for the remaining duration of the programme. This is set out in the Financial Provisions of the draft Withdrawal Agreement, which has been agreed by both UK and Commission negotiators and welcomed by the other 27 EU countries at March European Council. However, the government states that as a responsible government it needs to plan for every eventuality to ensure that cross-border collaboration in science and innovation can continue after EU exit.

EUROPEAN TERRITORIAL COOPERATION (INTERREG V)

[Interreg V 2014-2020 \(European Territorial Cooperation\)](#) is a framework for the implementation of joint actions and policy exchanges in Europe between national, regional and local actors from different member States. The framework is part of the Cohesion Policy and promotes innovation, a better environment and harmonious economic, social and territorial development of the Union as a whole. Interreg is built around three strands of cooperation: cross-border (Interreg A, 60 cooperation programmes), transnational (Interreg B, 15 cooperation programmes) and interregional (Interreg C, 4 cooperation programmes.). There are [11 thematic objectives](#) which guide the ERDF investments 2014-2020 of which Interreg is part. Conserving, protecting, promoting and developing natural and cultural heritage is one of the [investment priorities](#) (priority 6c).

Interreg Europe (former IVC)

[Interreg Europe](#) helps regional and local governments across Europe to develop and deliver better policy. The programme facilitates exchange platforms and co-finances projects in which regional and local authorities (and other partners) can exchange good examples and ideas on public policy to improve the strategies for their citizens and communities. Specific objective 4.1 (see page 21-23 of [Programme Manual](#)) includes support to cultural heritage. The [fourth call for project proposals](#) closed on 22 June 2018. A Monitoring Committee will take a decision on the approval of applicants in March 2019.

URBACT

Third Faro Convention Network gathering 19-20 December 2018

Hosted by the Nouvelle Aquitaine regional authorities, [the annual gathering of the Faro Convention’s](#) inspired initiatives took place in Bordeaux (France) with the participation of facilitators of 20 initiatives from 11 Council of Europe member States.

Participants discussed both the respective progress of the projects developed by each initiative participating in the Network, and possible developments in 2019, emphasising the future interactions between these initiatives through the definition of a coordinated plan.

The meeting also allowed direct exchange with existing local initiatives also inspired by the Faro Convention principles and revealed more about the regional authorities’ commitment to promoting cultural rights, particularly in the heritage field within the new French decentralization law reinforcing the competences of the Regions.

First Regional Seminar of the European Commission/Council of Europe joint programme “The Faro Way” (13-14 December, 2018, Madrid, Spain)

As part of the [European Year of Cultural Heritage](#) and in co-operation with the Spanish Ministry of Culture and Sports, a first seminar of the joint project [“The Faro Way: enhanced participation in cultural heritage”](#) brought together in Madrid on 13-14 December 2018 representatives from seven countries, several Spanish regional authorities and selected international experts.

Through presentations, discussions on selected topics and field visits to two heritage-driven initiatives, the seminar provided an opportunity to better understand the Faro Convention approach to cultural heritage and to exchange on the concerns that authorities may have in supporting the Convention through signing, ratifying and implementing it.

#EuropeForCulture – Closing Conference of the European Year of Cultural Heritage 2018 (6-7 December, Vienna, Austria)

Heritage professionals and policy makers met in Vienna on 6-7 December to close the programme of the European Year of Cultural Heritage.

After 12 months and over 11,700 events involving 6.2 million people, the Year successfully raised public awareness, disseminated examples of good practice, and promoted policy debates, research and innovation in cultural heritage. The conference highlighted projects, innovative methods of cultural education and established cultural heritage partnerships. Cultural heritage, education and youth: UNESCO and the European Union launch a new project

Marking the European Year of Cultural Heritage 2018, UNESCO and the European Union teamed up to develop a new project to start in 2019 that strengthens the connections between cultural heritage, youth and education. The project has two main components: one seeks to empower a new generation of heritage professionals and another aims to bring intangible cultural heritage into the classroom. UNESCO will organize the [Young Heritage Experts Forum](#) to be hosted in Zadar, Croatia in the first half of 2019, which will bring together 28 young experts from across the European Union. They will engage in a series of activities related to the safeguarding and protection of their cultural heritage. Through workshops, group discussions, hands-on experiences and site visits, participants will learn from each other, create synergies and reinforce their aptitudes and skills. As a result, the Forum will empower them to become better advocates of cultural heritage and enable them to implement sustainable projects on heritage protection and safeguarding in their home countries.
