EUROPEAN UNION

EU supports Ukraine through culture

The European Commission is mobilising its instruments to support Ukrainian artists and culture professionals and to support the protection of cultural heritage. Mariya Gabriel, EU Commissioner for Innovation, Research, Culture, Education and Youth, said: "I would like to express my full solidarity with the Ukrainian artists, creatives, culture professionals, and of course, cultural heritage and all cultural and creative sectors. They are the beating heart of Ukraine, and their work epitomises the Ukrainian history, identity, language, and hopes for the future. They are also part of our common European identity, made of a mosaic of cultures, in full respect of cultural diversity." Read full statement [here](#).

Education, Youth, Culture and Sport Council - Culture, Audiovisual, Media and Sport

(April 2022) The Council approved conclusions on reinforcing intercultural exchanges through the mobility of artists and cultural and creative professionals, and through multilingualism in the digital era. These conclusions call on member states to **promote cooperation between cultural authorities and those responsible for administrative issues related to mobility**. The EU wishes to encourage mobility and exchanges among European artists and creative and cultural professionals, in particular by guaranteeing them better access to mobility opportunities within the EU. The conclusions also call for the development of an **ambitious digital policy** for the **development of language technologies**, translation and

lifelong language learning and teaching. The EU wants to take advantage of new technologies to foster multilingualism, which nurtures cultural exchanges and facilitates access to culture.

The Council also approved conclusions on building a European strategy for the cultural and creative industries ecosystem, a sector that employed 8.02 million people in the EU in 2019. The strategy is structured around five pillars:

- improving access to finance for European businesses in the cultural and creative industries ecosystem;
- stimulating skills development and enhancement, as well as education and training;
- preserving and reaffirming Europe's cultural richness and diversity in the digital age;
- strengthening exports by businesses in the cultural and creative industries ecosystem;
- promoting responsible policies in businesses in the cultural and creative industries ecosystem.

The Conference on the Future of Europe

Chairs and spokespersons of nine Working Groups at a plenary session, on 8-9 April, tabled consolidated draft proposals, grouped by theme, to the Conference plenary. The proposals were mainly based on the recommendations of European Citizens' Panels, national panels, and ideas from the Multilingual Digital Platform. These proposals were discussed by all Plenary Members. The final Conference Plenary session is scheduled for 29-30 April in Strasbourg, where proposals are expected to be approved by the Plenary on a consensual basis, with a final say of the citizens component. These proposals will be then put forward to the Conference's Executive Board, with the final report delivered to the Presidents of the EU institutions on 9 May in Strasbourg for the closing ceremony of the Conference. Committees of the European Parliament: 2023 Budget - Section III

The 2023 EU budget will be the third under the multiannual financial framework (MFF) for 2021 to 2027. It is also the last year of the EU recovery instrument (Next Generation EU), which is planned to run from 2021 to 2023. The draft guidelines, as adopted by the Committee on Budgets on 16 March 2022, outline Parliament's goals for the Union's 2023 budget, with the overarching priority of recovering from the coronavirus crisis and facing geopolitical challenges. Parliament is expected to adopt its guidelines during the April plenary session, ahead of the Commission's adoption of its proposal of the draft 2023 budget, scheduled for early June. COUNCIL OF EUROPE

Archaeology and digital technologies: thematic session at the 10th plenary session of the CDCPP

A thematic session on the subject of archaeology and digital technologies, with particular reference to the European Convention on the Protection of the Archaeological Heritage (revised, Valletta, 1992) was held in December 2021. Both EAC and EAA representatives attended the session. At the dawn of the 30th anniversary of the Convention in 2022, the CDCPP is exploring how digital technologies can inform or contribute to the implementation of the Valletta Convention, analysing not only the successes, but also the obstacles and challenges along the way, as well as the future prospects and opportunities. Russian Federation

On 25 February 2022, following an exchange of views with the Parliamentary Assembly, the Committee of Ministers decided to suspend the Russian Federation from the Council of Europe in accordance with Article 8 of the Statute. On 16 March, at an extraordinary meeting, the Committee of Ministers decided, in the context of the procedure launched under Article 8 of the Statute of the Council of Europe, that the Russian Federation would immediately cease to be a member of the Council of Europe, ending its 26 years of membership. BUDGETS AND PROGRAMMES

Multiannual Financial framework (MFF)

The multiannual financial framework for 2021-2027 is in place as of 1 January 2021. As a result, €1.074 trillion will become available for beneficiaries of EU funding during the next seven years. CREATIVE EUROPE

With an annual budget of €385,6 million, nearly €100 million more than 2021, Creative Europe strengthens its support to the cultural and creative sectors, taking due account of the challenges resulting from the COVID-19 crisis and the growing global competition. Some of the actions covered by the Creative Europe Culture Strand in 2022:

- European cooperation projects Calls under the flagship action European cooperation projects will be launched in February 2022 and target all cultural and creative sectors to foster transnational cooperation, exchanges of practices, joint production and innovation.
- Performing arts and cultural heritage In the second half of 2022, 3 new calls will be published to support the music sector through Music Moves Europe, the performing arts sector through the Perform Europe initiative and cultural heritage through quality support to the European Heritage label action.
- Books and literature In 2022, Creative Europe supports the translation of literary works and the development of publishing partnerships, as well as the European Book Week, an initiative to foster reading among young people.
- Prizes and initiatives In 2022, the Culture strand of Creative Europe continues to support the organisation of four yearly European EU Prizes in the fields of literature, music, architecture and cultural heritage, in the form of grants, as well as the European Capitals of Culture initiative. Emphasis is given to knowledge-sharing, networking and promotion opportunities for winners.

THE CITIZENSHIP, EQUALITY, RIGHTS AND VALUES PROGRAMME (CERV)

Citizens, Equality, Rights and Values (CERV): EU program 2021-2027

A new EU funding period begun in 2021. The "Europe for Citizens" program, together with the REC (Rights, Equality and Citizenship) program and Daphne, form the EU program "Citizens, Equality, Rights and Values 2021-2027" - CERV for short. CERV - with a budget of around EUR 1.55 billion - will consist of four funding areas with the general goal of maintaining and developing open, rights-based, democratic, equal and inclusive societies. The priorities of "Europe for Citizens" remain.

ERASMUS+

2022 Erasmus+ European Universities call – preliminary submission results after deadline

The 2022 Erasmus+ European Universities call for proposals closed on 22 March. Following the deadline, 52 proposals were received in total (eligibility check still to be performed). In total, the call attracted around 350 higher education institutions covering 33 EU Member States and third countries associated to the Erasmus+ programme. Find out more [here](#).

HORIZON EUROPE

Horizon Europe is the EU's key funding programme for 2021-27 for research and innovation with a budget of €95.5 billion. It tackles climate change, helps to achieve the UN's Sustainable Development Goals and boosts the EU's competitiveness and growth. The programme facilitates collaboration and strengthens the impact of research and innovation in developing, supporting and implementing EU policies while tackling global challenges. It supports creating and better dispersing of excellent knowledge and technologies, creates jobs, fully engages the EU's talent pool, boosts economic growth, promotes industrial competitiveness and optimises investment impact within a strengthened European Research Area. Legal entities from the EU and associated countries can participate.

The new Horizon Europe programme is structured around three pillars that are divided into specific subjects. For the first time ever, the authors of the programme included a cluster dedicated to Culture, Creativity and Inclusivity.

UK participation in Horizon Europe

UK researchers remain eligible to apply to Horizon Europe. The Trade and Cooperation Agreement between the EU and the UK provides for the possibility of associating the United Kingdom to Horizon Europe, subject to the adoption of a Protocol. As this Protocol has not been adopted so far, the UK is still considered to be “non-associated” to Horizon Europe. The successful proposals of applicants based in a country in the process of associating to Horizon Europe will be eligible for funding only if the relevant Horizon Europe association agreement applies by the time of the signature of the grant agreement. However, successful applicants from UK host institutions can still be funded provided they move to a host institution in an eligible country. If the delay to the UK association continues, the UK government has confirmed successful Horizon Europe applicants will receive funding from UKRI regardless of the outcome of the UK’s efforts to associate with Horizon Europe. POST-2020 EUROPEAN TERRITORIAL COOPERATION PROGRAMMES “INTERREG”

In January 2022 the European Commission, formally adopted two Implementing Acts that define the scope of Interreg programmes for the 2021–2027 period. Interreg funds projects that bring together policy organisations from across Europe. For four years, they learn from each other and work together on a shared policy issue. The lessons they learn lead to the improvement of regional policies and a more sustainable economic, social and environmental impact on the ground for the people and the place they serve.

ECHA's plan to include lead in the list of substances subject to authorisation

April 2022: ICOMOS, ICOM, ECCO, ICOMOS-Corpus Vitrearum ISCCSG and ICOM-Glass issued a joint statement to raise severe concerns about the European Chemicals Agency's (ECHA) plan to include the material lead in Appendix XIV (Authorisation List) of the REACH Regulation. This would not only pose a major threat to the conservation, maintenance, presentation and even the creation of a large number of art and cultural objects, but would also destroy the livelihoods of countless conservator-restorers, craftsmen and artists, an economic, cultural and social impoverishment on a massive scale. March 2022: Europa Nostra and EIB Institute announced Europe's 7 Most Endangered heritage sites 2022. The Programme forms part of a civil society campaign to save Europe's endangered heritage. It raises awareness, prepares independent assessments and proposes recommendations for action. It also provides a grant of €10,000 per listed site to assist in implementing an agreed activity that will contribute to saving the threatened site. How can Artificial Intelligence benefit the Cultural Heritage sector?

Cultural heritage professionals aim to improve the way we understand paintings by generating descriptions of them. However, since millions of cultural objects have been created throughout history, completing such a task seems impossible, but only for humans. The goal of the Saint George on a Bike (SGoAB) project is to provide high-performance metadata enrichment capability by using High Performance Computing (HPC) resources in the cultural heritage domain. The project trains natural language processing and deep learning algorithms in culture, symbols, and historical context to

automatically generate rich metadata for hundreds of thousands of images from various European cultural heritage repositories. Find out more [here](#).
