EUROPEAN UNION

Provisional agreement on European Year of Cultural Heritage 2018

The Council of the EU and the European Parliament have [reached a provisional agreement on the decision to designate 2018 as the European Year of Cultural Heritage](#) (EYCH 2018). The EYCH 2018 will have a specific budget line of 8 million euros. It was also agreed that representatives of the European Parliament can participate as observer in preparatory meetings of national coordinators to be organised by the Commission. Coreper already [endorsed the agreement](#) and as a next step the Parliament will vote on it at its [next plenary session on 26-27 April 2017](#). If the Parliament adopts the compromise text as approved by the Coreper, the Council will adopt the text in first reading without amendments. As the final decision comes closer, national authorities and many other stakeholders have already started preparations for activities during the EYCH 2018.

Follow-up EU strategy for international cultural relations

In June last year, the European Commission and the EU High Representative for Foreign Affairs and Security Policy presented a [joint communication](#) on an EU strategy for international cultural relations (see [European Affairs Update – July 2016](#)). Cooperation on cultural heritage is one of the three main priorities in this strategy. Both the Council and the European Parliament are now working on the follow-up to bring this strategy to life. The Maltese Presidency of the Council organised a [conference on the topic 'Cultural Diplomacy: Fostering International Cultural Dialogue, Diversity and Sustainability'](#) on 9 March 2017. At this conference, [Commissioner Tibor Navracsics delivered a speech](#) in which he stressed that we need to move away from the more traditional forms of cultural diplomacy and instead develop an attitude of dialogue, mutual listening and learning. He announced that the Maltese Presidency has decided to develop Council Conclusions on the topic. MEPs Elmar Brok (Foreign Affairs Committee) and Silvia Costa (Culture and Education Committee) are also working on [a draft report on this topic](#).

Consultation on the future of the Common Agricultural Policy

The European Commission has [launched a public consultation on the future of the Common Agricultural Policy \(CAP\)](#). The EU's agricultural policy ensures a decent standard of living for farmers, at the same time as setting requirements for animal health and welfare, environmental protection and food safety. It also supports sustainable rural development. The objective of the consultation is to gather input for the modernisation and simplification of the CAP. All interested stakeholders are invited to share their views on the future of the CAP. This consultation might be of interest to cultural heritage stakeholders too as cultural heritage is an important aspect of agricultural landscapes. [The consultation](#) is open until 2 May 2017.

COUNCIL OF EUROPE

Adoption of Recommendation on European Cultural Heritage Strategy (CM/Rec(2017)1)

At its meeting in February, the Committee of Ministers adopted the Recommendation on the European Cultural Heritage Strategy for the 21st century (Strategy 21). This Strategy was drafted as a follow-up to the [Namur Declaration](#). A big group of experts from various members States was involved in

the process. The Strategy pursues an integrated and inclusive approach to cultural heritage and promotes good governance and participatory heritage management. It sets challenges, provides recommendations and helps to disseminate examples of innovative and good practices. More information about Strategy 21 can be found [here](#). Launch of thematic report on culture and democracy at Compendium meeting

The Council of Europe has launched a first thematic report on culture and democracy: '[Cultural participation and inclusive societies - A thematic report based on the Indicator Framework on Culture and Democracy](#)'. It was launched during the [Assembly of Compendium Stakeholders and Experts](#) held in Nicosia, Cyprus on 30 and 31 March 2017. This was an important meeting for the [Compendium of Cultural Policies and Trends](#), because the information and monitoring system is changing into a new consortium with an open, multi-stakeholder governance structure. Stakeholders discussed the future of this new consortium, including its desired content and legal and financial challenges. More information about the Compendium can be found [here](#).

9th Council of Europe Conference on the European Landscape Convention

Each year the Council of Europe organises a [conference focussed on the implementation of the European Landscape Convention](#). The 9th edition of this conference was held under the auspices of the Cypriot Chairmanship on 23-24 March 2017. The event was attended by representatives of member States and a broad range of stakeholders, among which the EAC. A report of the meeting is available [here](#). One of the sessions focussed on the contribution of landscape to democracy, human rights and sustainable development. Two experts had prepared a very interesting [report on this topic](#), which is worth reading. The CoE Secretariat will prepare a draft Recommendation on this topic, based on two draft Recommendations prepared by the Working Group on Landscape and Democracy. For this conference, reports were also produced on topics such as [public landscape funds](#), [funding opportunities](#), [agricultural landscapes](#) and a [grammar for landscapes](#).

Funding and investments

CREATIVE EUROPE

The Creative Europe programme aims to support culture and audiovisual sectors in Europe and encourages players to operate across Europe, to reach new audiences and to develop skills needed in the digital age. The next call for [European Cooperation Projects](#) is expected to open in December 2017, with a deadline in the first months of 2018. The European Commission has published an [open consultation on the operation of the Creative Europe programme](#). With this consultation, the Commission wants to gather input for the mid-term evaluation of the programme. The consultation is open until 16 April 2017.

Cultural and creative sector guarantee facility

In 2016, the European Commission and the European Investment Fund (EIF) launched a new guarantee facility under the Creative Europe programme to support SMEs in cultural and creative sectors. Financial intermediaries are already operating in Spain, France and Romania and more are expected to follow. For more information, see [this page](#).

EUROPE FOR CITIZENS

The Europe for Citizens programme aims to strengthen remembrance and to enhance civic participation at EU level. Under the strand 'European remembrance' the programme promotes debate, reflection and cooperation in the field of European integration and remembrance. The 'Democratic engagement and civic participation' strand supports projects aimed at enhancing democratic participation, solidarity and involvement at EU level. ERASMUS+

The Erasmus+ programme aims to boost skills and employability, as well as modernising education, training, and youth work in Europe. The 2017 [call for proposals](#) supports several kinds of actions in education and training such as sector skills alliances and strategic partnerships. JPI ON CULTURAL HERITAGE AND GLOBAL CHANGE

The [Joint Programming Initiative on Cultural Heritage and Global Change \(JPI CH\)](#) supports the alignment of cultural heritage research in Europe in order to avoid fragmentation and to maximize the efficiency and added-value of national investments. In 2016 the JPI CH launched [a new 4-year \(Horizon 2020\) project](#) which will support further alignment and joint activities. During this 4-year phase JPI CH will launch four complementary calls each with a specific thematic focus. The call on digital heritage is about to open (20 April 2017). All documents will be available at the JPI CH website. A second call on changing environments is currently being developed and is expected to open in June.

The JPI CH organised a Funded Research Projects Parade on 20-21 February 2017. The aim of the Parade was to provide more visibility on JPI CH activities and give a new impetus to cultural heritage dedicated research, by presenting most recent research results. HORIZON 2020

Horizon 2020 is the EU's main funding programme for research and innovation in Europe. It is a financial instrument implementing the Innovation Union, a Europe 2020 flagship initiative aimed at securing Europe's global competitiveness. The business and academic world are also challenged to come up with solutions and ideas to tackle societal issues that arise across Europe, such as climate change and an ageing population.

Cultural heritage research and innovation in 2016 and 2017

Over €100 million is available this term (2016-17) for research and innovation in the field of cultural heritage. The H2020 programme is built around three pillars: Excellent Science, Industrial Leadership and Societal Challenges and some horizontal actions. Depending on your work area or research interest opportunities might be found under all pillars. Preparation of new Work Programmes 2018-2020

Preparations for the new Work Programmes 2018-2020 started in 2016. Stakeholder consultations and consultations with Member States have taken place in the first three quarters of 2016. The results of stakeholder consultations and Advisory Group recommendations provided input for so-called 'scoping papers', which are the basis for the new Work Programmes 2018-2020.

The European Commission has published [17 scoping papers](#) and one general [overarching document](#) for the Work Programmes 2018-2020. These scoping papers are working documents and therefore don't have any formal status. They do give a good idea of possible themes and priorities, as they will guide the preparation of the new work programmes. It might be worth to check out relevant sections of the scoping papers for SC5 (2.6 'Protecting and valorizing our natural and cultural assets') and SC6 (2.2 'Cultural and technological transformations for human and social progress'). The adoption and publication of the work programmes are expected in October 2017. For more information, [see this page](#).

EUROPEAN TERRITORIAL COOPERATION (INTERREG V)

[Interreg V 2014-2020 \(European Territorial Cooperation\)](#) is a framework for the implementation of joint actions and policy exchanges in Europe between national, regional and local actors from different Member States. The framework is part of the Cohesion Policy and promotes innovation, a better environment and harmonious economic, social and territorial development of the Union as a whole. Interreg is built around three strands of cooperation: cross-border (Interreg A, 60 cooperation programmes), transnational (Interreg B, 15 cooperation programmes) and interregional (Interreg C, 4 cooperation programmes.). There are [11 thematic objectives](#) which guide the ERDF investments 2014-2020 of which Interreg is part. Conserving, protecting, promoting and developing natural and cultural heritage is one of the [investment priorities](#) (priority 6c).

Interreg Europe (former IVC)

Interreg Europe focuses on policy instruments for regional development, in particular the Structural Funds programmes. The programme co-finances projects and exchange platforms in which regional and local authorities (and other partners) can exchange good examples and ideas on public policy to improve the strategies for their citizens and communities. Specific objective 4.1 (see page 21-23 of [Programme Manual](#)) includes support to cultural heritage. A [third call for project proposals](#) is now open until 30 June 2017. The [Terms of reference for this call](#) indicates that applications under priority axis 4 'Environment and resource efficiency' (this includes specific objective 4.1) are particularly encouraged. Interreg Europe also recently published a new [policy brief on cultural heritage in urban areas](#).

URBACT

URBACT supports networks for cities to facilitate the exchange of good practices in the design and implementation of sustainable integrated urban policies. The programme supports three types of networks. Cultural heritage is one of the urban topics under URBACT. EHHF Economic Taskforce starts ESPON Targeted Analysis project

The [Economic Taskforce of the European Heritage Heads Forum \(EHHF\)](#) has successfully applied for a Targeted Analysis at ESPON (European Territorial Observatory Network). The [ESPON programme](#) supports the production and dissemination of territorial evidence, because evidence is considered essential for informed policy making. The Targeted Analysis project of the Economic Taskforce is titled 'Cultural Heritage (CH) as a strategic territorial development resource; mapping impacts through a set of common European socio-economic indicators.' Questions to be answered are: How can we

define the socio-economic impact of cultural heritage?; In which economic domains does it play a role of significance and how can we measure this? The objective of the analysis is to formulate a set of socio-economic indicators for immovable cultural heritage that is meaningful and internationally comparable and to provide data for these indicators for a selection of European countries/regions. The project will be supported by ten stakeholders of which one lead stakeholder, the Norwegian Directorate for Cultural Heritage, and nine participating stakeholders. UN Security Council adopts resolution on cultural heritage protection

At its meeting on 24 March 2017, the United Nations Security Council unanimously adopted a [resolution on the protection of cultural heritage in armed conflicts](#). This is the first-ever resolution of the Security Council that focuses on cultural heritage. UNESCO Director-General Irina Bokova stressed in her briefing the importance of heritage protection for peace and security: 'Weapons are not enough to defeat violent extremism. Building peace requires culture also; it requires education, prevention, and the transmission of heritage. This is the message of this historic resolution.'. She also explained that international actors are working together to disrupt terrorist financing through the illicit trafficking of antiquities. G7 Culture Ministers adopt Florence declaration on 'Culture as an instrument for dialogue among peoples'

The Ministers of Culture of the G7 came together for a meeting on 30 and 31 March 2017 in Florence, Italy. At this meeting the members of the G7 adopted [a joint declaration on 'Culture as an instrument for dialogue among peoples'](#). This so-called Florence declaration recognises the role of culture as an instrument for dialogue and stresses the importance of common and coordinated action to strengthen the safeguarding of cultural heritage.
